AUTISM SPECTRUM DISORDERS: A DEEP DIVE INTO UNDERSTANDING THE DIAGNOSIS AND TREATMENT OF ASD

According to the CDC, one in 36 (2.8%) of 8-year-old children have been identified with an autism spectrum disorder (2023). Autism spectrum disorders are complex, developmental conditions involving persistent challenges with social communication, restricted interests, and repetitive behavior. Given the complexity of autism and the impacts the disorder can have on multiple areas of development, it makes sense that treatment be multidisciplinary. However, many professionals across mental health professions do not have specific training in autism. The fields with the most in-depth training are behavior analysis and psychology. However, other professionals such as mental health counselors and social workers would also benefit from in-depth training on detecting red flags for the disorder and providing evidenced-based care given the likelihood that they will encounter clients affected by autism. This training will provide a deeper understanding of autism spectrum disorders in terms of symptom manifestation and changes across the lifespan of the individual. It will overview evidenced-based therapies for autism and provide guidance to counselors on how to interact and support families affected by autism.
